No knock on many here. The godolphin pair, **ATMOSPHERE** and **TAMERLANE** tan the quinella and moved nicely.

Trial 4 - 9:00AM 3YO+ MAIDEN TRIAL (1030 METRES)

The lightly raced maiden galloper **OSTRAKA** moved well here and made strong ground late in the piece. It was the colts second trial this time in and he looks ready to head to the races now. Suggest he steps out over 1200m first up before getting over further deeper into his campaign.

Trial 5 - 9:10AM OPEN TRIAL (900 METRES)

Good field with the race fit and in form **BUENOS NOCHES** taking out this trial from **ZAPATEO** who goes into the blackbook. Loved the fact **ZAPATEO** matched motors with BN and ran right through the line. She's a class mare and has clearly come back in good order off a last start G1 placing. She can give the right race a shake first up.

Trial 6 - 9:20AM OPEN TRIAL (900 METRES)

MARS MISSION trialled well, showing speed to lead throughout. He tired late and will take benefit from this trial.

DEMIANA made very good ground down the outside and looks in fantastic order. Also liked the way **LONRIOLI** moved and ran through the line.

Another very stylish performance by **OZZMOSIS**, taking out this trial impressively. He looks a star colt on the rise, winning his two starts impressively and has clearly come back in good order. What was impressive about this trial is the way he settled in behind a very slow tempo, responding when asked late in the piece. He is a smart son of Zoustar.

Trial 9 - 9:50AM 3Y+ TRIAL (900 METRES)

KEYSBOROUGH went out fast but stoped as if shot. **AFTERLIGHT** set out after the leader and won this by a huge margin. The daughter of I Am Invincible took a long time to break her maiden but she's going to be first up off a win, and a trial win and if placed correctly, will be hard to beat. Her starting price of \$8.50 in a Scone Maiden suggests she won't be hard in the betting fresh.

Trial 12 – 10:20AM 3YO+ MAIDEN TRIAL (900 METRES)

Really excited by the performance of **INVINCIBLE EMMA** here and hoping a few have missed her. Loved her work through the line, with limited galloping room and loved what she did when getting into the clear. Powerful turn of foot! Zac Lloyd rode here which is a positive, although he is a light weight, well balanced rider. Irrespective, this daughter of Dundeel is yet to debut and this was her first public appearance. Loved her work and looking forward to seeing this Hawkes galloper on debut.
