Racing NSW map has a solid early tempo with JUST WAI and ISHANI leading the way. We're not sure it will pan out exactly like that with some others having speed also.

Our blackbooker #4 ARE EE QUE has shown speed and can be close from the inside barrier. Loved this fillies trials and we have a very big opinion of Shaken who beat her in her most recent work. If you missed it yesterday, Shaken won extremely well, franking what was a lovely trial by ARE EE QUE in behind. This filly looks like she has an action that will see her get through the wet and from barrier 1, she should get every chance. Rachel King knows her well after riding in both trials this time in and she'll just need to get her clear at the right time from barrier 1. Fitness the main query on the wet track first-up for the Quinton yard but tipping this filly will be hard to beat today.

## **Race 3 – 5:47PM CAPEL VALE WINERY 3YO+ MAIDEN (1111m)**

Track is a Good 4 with the rail in the +4m position. Bunbury is generally a fair track where most runners get their chance, and the race shape plays more part than the pattern.

#5 HIT THE JACKPOT has come up quite short in the market at it's first run this prep. Showed some ability last time but notably his two runs were on a Soft7/Heavy 10 which he seems to relish. Resumes here off only one 400m trial and happy to let it go around without us.

#6 ON A WINNING DAY is having her first start for the Michael Lane stable after previously campaigning in Victoria. Her form was only moderate there, but Lane has a good record with tried horses and her two trials for the stable have been very good. Love the way she worked to the line under no pressure in her first Lark Hill trial on 27/11 and she impressed again when strong through the line when asked for an effort in her trial on 11/12. She's top pick.

#10 ROMMEL'S GODDESS is the race fit horse and has drawn well in gate 1 for Brad Parnham. Settled outside the leader and battled on okay at her most recent start and if she gets a soft run from the inside draw, she will be in the finish. #11 BIRD ON A WIRE and #12 LADY DUCATI come through the same trial at Lark Hill on 11/12. Thought Bird On A Wire was the pick of the two through that heat, settling back and running through the line nicely. She is some chance but have others ahead.
